**Professional Development Scholarship Opportunities  
for Washington State Treatment Providers**

Thank you for your interest in the professional development scholarship opportunities for Washington State treatment providers to attend the **Focus on the Future** conference May 6-9, 2019. The scholarships were established, with the support of Washington State Behavioral Health Administration, to encourage and support participation by professionals who have applied to become a Washington State certified gambling counselor and hold a current certificate or license issued by the State of Washington to provide mental health or chemical dependency treatment services to the public.

Applications for certification are available online at [www.evergreencpg.org](http://www.evergreencpg.org) or by calling the Evergreen Council on Problem Gambling (ECPG) at 360.352.6133. Treatment providers with applications on file by April 19, 2019, are eligible. A limited number of professional development scholarships are available (total value up to \$675) that will include:

- Registration for up to four days (pre-conference and main conference – May 6-9, 2019).
- Washington State Gambling Certification application fees (for those who have not yet applied).
- Hotel stipend of \$50 per night, up to three nights, for any scholarship recipient who books his/her room at the Great Wolf Lodge®. Additional lodging costs, meals, and travel expenses are the responsibility of the attendee.

**CONTINUING EDUCATION/CERTIFICATION**

All Evergreen Council on Problem Gambling (ECPG) workshops qualify toward the 30 hours of gambling-specific education required by the Washington State and National Problem Gambling Certification Boards. ECPG is an Approved Provider of Continuing Education by The Association for Addiction Professionals (NAADAC) and the National Council on Problem Gambling (NCPG). Our workshops have also been approved for continuing education by the Mental Health and Addiction Certification Board of Oregon (MHACBO), the American Academy of Health Care Providers in the Addictive Disorders (AAHCPAD), and the Washington Mental Health Counselors Association (WMHCA). Approval is pending for CLE credits through the Washington State Bar Association.

## ELIGIBILITY

### Professional development scholarship recipients **MUST**:

- Download registration form at [www.evergreencpg.org](http://www.evergreencpg.org) and FAX or email to ECPG (scholarship recipients cannot complete registration form online). **Conference registration MUST be sent in with scholarship application.**
- Be a current ECPG member. Visit [www.evergreencpg.org](http://www.evergreencpg.org) → **Membership** or fill out the form in this application.
- Have a completed Washington State problem gambling counselor certification application on file with ECPG by April 19, 2019, which is available at <https://www.evergreencpg.org/training/counselor-certification-info/> and hold a current certificate or license issued by the State of Washington to provide mental health or chemical dependency treatment services to the public. All scholarship recipients must commit to completing the Washington State problem gambling counselor certification requirements within two years of certification application.

**OR**

- Provide proof of successful completion of a Recovery Coach Academy® Training with a copy of the signed and dated Certificate or a signed and dated Certificate from another SAMHSA-approved Peer Recovery Coach Program.

**OR**

- Provide proof of enrollment in a Washington State college or university Behavioral Health, Addictions, or Counseling program.

## DEADLINE

Completed scholarship application form and supporting documentation—with a completed conference registration form—must be postmarked by **April 19, 2019**. Applications received after this date will be considered only if funding is available.

## AWARDS

Professional development scholarship recipients will be notified by April 26, 2019.
